## About this course

**The COVID19 pandemic has highlighted the importance of building the capacity and understanding of the workforce across a range of areas.**

These measures will assist in providing a safe environment and hygiene practices when preparing, handling, serving and assisting with meals. ## Important information

This skill set will be delivered through a mix of online training and on campus practical laboratory and simulated sessions.

You will be required to attend 4 days on campus as part of the training.

Employers within the aged care and community services sector use a values based model for employment supported by the relevant skills and qualifications.

Working with children check/police clearance will be required to undertake work in the aged care, community services and health sector.

## Fees and charges

### Local full time students

Course fees are made up of two components, tuition fees and resource fees.

**Tuition fees** are determined by multiplying the course fee rate by the nominal hours, which is the number of hours in which an average student could be expected to complete each unit. They are not the hours of training or instruction.

**Resource fees** are charges for material that are essential to a course or unit, and are purchased by NMT to be used by students during the course.
